**6:00 P.M., WEDNESDAY, April 11, 2018**

after which time no entries may be accepted, canceled, altered or substituted, corrected, completed or signed and no entry fees refunded. Telephoned and telegraphed entries are not accepted. All changes and cancellations must be received in writing prior to closing, except as provided for in Chapter 11, Section 6 of the *Rules Applying to Dog Shows* published by the American Kennel Club.

**Entries** – Entries not on an official AKC entry form are not acceptable and photocopies of the entry form must have the Agreement and Instructions on the reverse side. Owners are responsible for errors on entry blanks, whoever may make such errors. Entry fees will not be refunded in event of errors or cancellation of entries after the published closing date, nor in the event that a dog is entered twice, comes in season, absent, disqualified, excused by the Veterinarian or Judge or barred from competition by the Show Committee. If, because of extreme weather conditions, riots, civil disturbances, or other acts beyond the control of the management, it is impossible to open or complete either show, no refund of entry fee(s) will be made.

**Faxed Entries** – To fax an entry or attach an entry to email, use PayPal services, payable to the account for PARRKEES@mac.com. Add \$4.00 for each entry form to the correct entry fee amount. Fax number is (760) 946-9048. Email address is PARRKEES@mac.com. You must send the front and back of entry form for it to be accepted, completely filled out and signed. Notification must be received by the show secretary from PayPal that the funds have been deposited before the entry will be accepted.

**Insufficient Funds** – Checks not covered by sufficient funds do not constitute a valid entry fee. The Show Chairman will add a collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitor will result in that exhibitor being put on a cash-only basis.

**AKC Recording and Event Service Fees** – Collected by the club and paid to the American Kennel Club, recording and event service fees are required for each entry at each show. Exceptions: no recording fee or event service fee for sweepstakes, futurities, brace/team, multi-dog classes, or special attractions. (*Rules Applying to Dog Shows* Chap. 11, Sec. 2).

**Entry Acknowledgement** – If exhibitor's ticket and judging program are not received within a reasonable time prior to the show, notify the Show Secretary at (760) 946-9048. Consult the judging programs for time of judging. If it is desired that an agent receive a judging program and copy of exhibitor's ticket, include name and address with a request to do so.

**Move-ups to Best of Breed or higher class in Obedience** – Dogs which according to their owner's records have completed the requirements for a title after the closing of entries for the show, but whose title is unconfirmed, may be transferred from one of the regular classes to the Best of Breed or Variety competition or a higher obedience class provided this transfer is made by the Show Secretary at least one-half hour prior to the start of any regular conformation or obedience judging at the show, whichever is applicable.

**Judging** – Dogs may arrive any time prior to their scheduled judging time and unless needed for further judging, may be excused immediately after being judged. All dogs present must be held on leash or confined in their crates or exercise pens except when being judged. No dogs will be allowed in the show area except those entered in the show as there is no provision for unentered dogs. The judging will start promptly. The clubs and their show secretary will not be responsible and are not obligated to notify exhibitors or their agents of class judging. It is the responsibility of the exhibitor to have his dog ready to be shown and at the entrance of the judging ring when the steward calls for the class. Judges will not hold up a class by waiting for any dog.

**Loss or Damage** – The show committees will use due care and diligence for the welfare of dogs, exhibitors and spectators, but will not be responsible for, or assume any liability in the event of any accident or misfortune, to either dogs, exhibitors or spectators participating in these shows. By entering these shows the owner, exhibitor or handler agrees to hold harmless and indemnify Gateway Cities English Springer Spaniel Association, Inc. or the English Springer Spaniel Club of San Fernando Valley, Inc., their members, officers and boards of directors against claims or damages arising out of the conduct of any exhibitor and/or their dog or dogs. It is clearly understood that every dog entered in the show is in the care, custody and control of its owner or handler during the entire time the dog is on the show premises. Exhibitors are admonished not to leave any dogs unattended in vehicles. The welfare of an exhibitor's child is assumed to be the responsibility of the exhibitor. It is distinctly understood that exhibitors will exercise control and restraint over their children on the day of each show. **NOTE:** Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

**Trophies and Prizes** – Trophies and prizes will be awarded in the judging rings to the person exhibiting the dog, who will be considered to be the owner or agent of the owner. All claims for trophies and other prizes must be made in the judging ring before the completion of show and the show chairman be advised at once in the event of any discrepancy. No award will be mailed.

**AKC Rules Applying to Dog Shows** – Exhibitors are advised to make themselves familiar with the Agreement of the American Kennel Club on the reverse side of the entry form that accompanies the Premium List. AKC Rules, Regulations, Policies and Guidelines are available on the American Kennel Club web site, www.akc.org.

**Clean-up** – Exhibitors and handlers are responsible for clean conditions in and around their set-up, including the removal of dog hair.

## NON-REGULAR CLASSES INVOLVING SINGLE DOG ENTRIES

Veteran Dogs and Veteran Bitches – For dogs and bitches 7 years of age or older  
Note: Neutered dogs and spayed bitches may be entered in Veteran Classes at Independent Specialty Shows

## BEST OF BREED COMPETITION

The following categories of dogs may be entered and shown in Best of Breed or Variety Competition: Dogs that are Champions of Record. Dogs which according to their owners' records have completed the requirements for a championship but whose championships are unconfirmed. The entry and showing of dogs whose championships are unconfirmed is limited to a period of 90 days from the day of the show where the dog completed the requirements for championship according to the owners' records. If, at the end of the 90 day period, the championship has not been confirmed by the American Kennel Club, no further entries of the dog for Best of Breed or Variety Competition are to be made until its championship has been confirmed by the American Kennel Club.

## AWARDS OF MERIT

At his discretion, the judge may give to up to 10% of the Best of Breed entry.

## BEST PUPPY

For winners of the 6-9 mos. and 9-12 mos. Puppy Dog and Bitch Classes.

## NON-REGULAR CLASSES INVOLVING MULTIPLE DOG ENTRIES

**Stud Dog Class** – For dogs that have sired at least two dogs or bitches entered in this show. The award will be based on the merits of the get. As the judge's decision in this class will be based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in this class will be eligible to compete for Best of Breed by virtue of having won this class. The Stud Dog must appear in the ring with at least two, but not more than four of his get, and must be entered in the Stud Dog Class. The owner of the stud dog need not be the owner of the get.

**Brood Bitch Class** – For bitches that have produced at least two dogs or bitches entered in this show. The award will be based on the merits of the produce. As the judge's decision in this class will be based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in this class will be eligible to compete for Best of Breed by virtue of having won this class. The brood bitch must appear in the ring with at least two, but not more than four, of her produce, and must be entered in the Brood Bitch Class. The owner of the brood bitch need not be the owner of the produce.

Get must be entered in a regular class, best of breed competition, or some other non-regular class. §

**Brood Bitch Class** – For brood bitches and two but not more than five of their produce. Brood bitches must be entered in the Brood Bitch Class and must be shown in the ring with their produce. The owner of the brood bitch need not necessarily be owner of the produce. While the merits of the brood bitch are not to be considered in the placement of the entry, the brood bitch must be examined to determine if it has a condition that would require its disqualification or excusal under the "Rules Applying to Dog Shows," AKC policy or the standard for the breed. Produce must be entered in a regular class, best of breed competition, or some other non-regular class. §

\* Please note: The class for Dogs or Bitches, 12-18 months, is not a puppy class. For the American Kennel Club definition of Regular Classes, refer to Chapter 3, *Rules Applying to Dog Shows*.

† As per Chapter 11, Section 9 of the *Rules Applying to Dog Shows* "neutered dogs and spayed bitches may compete in the Veterans classes only at independent specialties and/or those all-breed shows which do not offer any competition beyond best of breed" and "a castrated male may be entered as a stud dog in the Stud Dog Class and a spayed bitch may be entered as a brood bitch in the Brood Bitch Class."

§ As the judge's decision in this class will be based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in this class will be eligible to compete for Best of Breed by virtue of having won this class.

### What is meant by Wild Card?

The designated classes follow the Obedience Regulations and requirements for each class level: Novice, Open, and Utility. The difference is that, when checking in for the class, the handler will identify one of the required exercises in that class as their wild card. The handler may choose to perform or not to perform the exercise, but in any case the dog and handler will receive a perfect score for this one exercise. If the handler chooses to perform the exercise, they must comply with the regulations in their performance. The wild card exercise is not meant to be a training opportunity for the dog and handler.

### Are there any prerequisites required to enter my dog in these classes?

No – A dog may be entered in these classes without any pre-title requirement.

### Can I talk to my dog while performing the required exercises of the class?

Yes – The class exercises will be performed and judged as in the regulations, except that verbal praise during the exercises, except that signal exercise in Utility, is to be encouraged and not penalized. Handlers may give additional commands, but they will be penalized accordingly.
